OFF ROAD VEHICLES IN TEXAS RIVERS

During the current legislative session (which began in mid January and will end in May) our lawmakers will be considering whether it should be illegal to drive vehicles within the publicly owned streambeds of Texas.

Texans place a very high value on our freedoms; and we are very protective of our rights to access our rivers. So none of us wants to keep someone from enjoying his or her favorite form of river recreation. But we (especially members of this organization) are also very concerned with protecting the natural beauty and environmental quality of our rivers; and if freedom and access must be limited to protect our rivers, then we have a duty to act.

There is no question that the streambeds of most navigable rivers in Texas belong to the people of Texas. It is much the same as the right of way along our highways, or the lands within the confines of a state park. So we will not argue that a person in an off road vehicle does not share in the ownership of most of the streambeds where he wants to drive. But just as that person may not drive off road on the right of ways along our highways, or randomly off road within a state park, he or she may not drive on streambeds that are sensitive, fragile ecosystems.

And there is no argument that driving within a streambed is harmful to the streambed. Wheels churn up the gravel, destroying vegetation and causing future erosion. Riverbanks are destabilized. Habitat is destroyed. Birds and animals sensitive to noise and heavy traffic are dislocated. Fish spawning grounds are ruined. Habitat for invertebrates that become food for fish is disrupted. Water quality is affected, both from the muddying of the water by the churning gravel and by oil spills.

On a recent trip to the Nueces River (where a disproportionate amount of off road vehicle traffic occurs) the destructive power of vehicles was easily noted. On a section of river that is commonly used by vehicles (starting at Highway 55 and proceeding downstream for approximately 3 miles) the gravel bars were very large and flat and contained almost no vegetation. Few birds were sighted, mostly because there were no trees in which they could perch. There was virtually no vegetation to control erosion, so the riverbed seemed destined to spread out wider and flatter with time. A wide, flat, shallow river will heat up more (especially in the absence of shade trees) thus changing the nature of the stream and the fish that can live there.

Then we passed an area where the channel was too deep for vehicular traffic, and fences keep the vehicles off the privately owned land above the gradient boundary. Suddenly there were trees growing along the riverbed, which was now more defined. Grasses and small trees inhabited the gravel bars, providing a home or birds and animals, which were now sighted. The river was suddenly deeper and narrower, the channel more defined. In short, we were now witnessing a healthy river, whereas a mile before we were seeing a river in bad repair.

In this issue you will find information on proposed legislation to protect our rivers from off road vehicle abuse. I hope you take the time to write your elected officials a letter supporting this legislation. The rivers of Texas will appreciate it.

Support Senate Bill 155

Additional Land Purchase at Hidalgo Falls

Two years ago a group of paddlers began an effort to purchase access to the Brazos River at Hidalgo Falls. This organization, along with the Texas River Recreation Association, became involved, and now the TRPA holds the title to ten acres of land – seven upstream of the rapid and three downstream. At the time the land was purchased, we acquired a right to buy other land at Hidalgo Falls as it became available. Our hope is to someday own as much as thirty acres of property there. Recently an additional two acres of land has become available and TRPA has made an offer of \$16,000 for that property. This land has a mobile home on it, which will be sold to Southwest Paddlesports to be used as an outpost for kayak lessons. This additional property will give us excellent access to the middle portion of the rapid. At this time we have received checks and pledges for over six thousand dollars, if you believe in this amazing and precedent setting approach to preserving access for paddlers in Texas please help. SMRF Water Right to be Considered by TCEQ

On March 19, the Texas Committee on Environmental Quality (formerly the TNRCC) will consider sending the application for water right filed by the San Marcos River Foundation to a hearing. SMRF has applied for a water right for water in the San Marcos and Guadalupe Rivers solely for the purpose of leaving that water in those rivers for instream uses and for the health of our bays and estuaries. So far TRPA has contributed \$8,000 to SMRF for this application and for other battles to protect the flow of the San Marcos River. Speaking of Membership...

Just as it has been with every non-profit organization in the country, times have been lean for the TRPA ever since 9/11/01. Donations are down, but we realize that your bank accounts aren't exactly up either. That is one of the reasons that we have cut corners (like less newsletters). Nonetheless, we have been able to continue our efforts to keep or rivers free and flowing. If you'll notice, we have spent \$2,678.82 this year on the battle to stop a water rights permit for a golf course on the Guadalupe River (that case is in the appeals process). We have also been able to donate \$5000 to the SMRF toward their water rights permit and another \$3000 to fight a bed and banks water right permit that has been granted to the City of San Marcos. Since there are no paid staff for this organization, and very few office expenses, almost every cent of your dues goes directly toward protecting our rivers. We believe we are the most efficient river protection organization in the country. So please, be as generous as possible when you renew your membership. The rivers of Texas will appreciate it.

THE 18 TH ANNUAL GREAT TEXAS RIVER CLEAN-UP

March 1, 2003

On Saturday, March 1, 2003, folks from all over Texas will be participating in the world's longest river clean-up. We will be picking up trash along the entire length of the San Marcos River (approximately 90 miles).

BANK CREWS

Everyone is urged to help. If you are unable to participate in the water, we need volunteers to work the banks of the river, especially at parks and highway crossings. Bring some trash bags (we will supply as many as possible) and perhaps a flounder gig to snag some goodies. Scuba divers and snorkelers are also urged to participate.

RECREATIONAL PADDLERS

We are asking recreational paddlers and canoe clubs to accept the challenge and volunteer for a section of river. If your group or club has not already been assigned a section, be sure to contact Tom Goynes and tell him what stretch you would like. The upper sections of the San Marcos River, particularly just downstream of the City of San Marcos, will require the most attention, and the short mileages set for these sections reflect this. Furthermore, the river becomes less accessible and more hazardous as one goes downstream. For that reason, novice boaters should volunteer for either sections 1 or 2 and more experienced boaters for the other sections.

SAFARI TEAMS AND CANOE RACING ENTHUSIASTS

The lower river, from Luling to Gonzales, has several long sections with few bridge crossings and for that reason, we are asking canoe racers and especially teams that have competed in the Texas Water Safari in the past to volunteer for sections 9 - 11.

CAMPOUT AND GET-TO-GETHER

Everyone participating in this event is invited to camp free at either Shady Grove Campground/ Spencer Canoes or at Pecan Park Retreat for the weekend. Starting at 6 p.m. on Saturday evening there will be a free barbecue provided by the San Marcos River Foundation at Shady Grove/Spencer Canoes. It should be noted that the party will terminate by midnight to allow the rest of the workers some time to sleep.

SUNDAY WORSHIP SERVICE

On Sunday morning at 8 a.m., there will be a non-denominational Christian worship service at Pecan Park. Duane TeGrotenhuis will lead the group in song and Tom Goynes will lead a short Bible study. Everyone is welcome.

WHAT YOU CAN DO

First of all, mark March 1st on your calendar. Secondly, look over the enclosed river section listing, and choose a stretch that you can help cover. Next, call me at 512-392-6171, and I will put you in contact with the group leader of the section you have chosen. Each leader will be able to help arrange shuttles and will be given logistical info regarding trash deposit locations as the clean-up nears.

MEETING TIMES AND SHUTTLES

A group meeting will be held for everyone working sections 3 through 7 at 9:00 a.m. Saturday morning at Spencer Canoes. Groups working sections 8 - 11 will arrange their shuttles as early as possible Saturday morning and try to put in the river by 9:00 a.m. Persons working sections 1 and 2 will meet at City Park in San Marcos at 10:00 a.m.

LET'S DO IT

Communities along the river are being urged to help in any way they can. If you can offer any service, such as trash hauling, shuttle driving, trash bags or food donations - anything - please give us a call.

Together we can clean up the whole river and make a strong statement to the public about our love for free flowing streams. Please help us out,
