#### A Brief History of River Time in 2022

Each of us is fortunate in that we have a hobby that puts us in out of harm's way. We all have had a long-time privilege of enjoying time on the river, on a stream, on a lake. We all know that time does not seem to exist by the water, it simply calms us, soothes us, bathes us and surrounds us. I don't know of anyone that isn't calmed by water.

It is difficult on some rivers to gain access, either put-in or take-out.

TRPA is going to keep forging on for these items. For years, Tom shouldered a lot of responsibility for this, and was assisted by the Board. His legacy (and Paula's) will be built upon, strengthened, and continued. TRPA is working on tighter coalitions with other groups to make sure issues are identified, communicated, and acted upon.

We are not forgetting the joys of paddling either. Check out the new river information section on the website. Want to suggest a river, or submit a trip report? That is now available too.

As part of all of the above, we are asking you to keep your membership current. We are also asking for you to get your family and friends to help us in our efforts. The Board serves as total volunteers, but we have to pay outside consultants and legal fees in our permit fights. How else can you so easily support such a worthy cause?

Have a great start to 2022, and I hope to see you at the Clean-up on March 5th, or sometime on one of our wonderful rivers.

# Annual Meeting, Sunday, March 6

On Sunday, March 6 at 10 a.m. the Texas Rivers Protection Association will hold its annual meeting in the Cowboy Chapel at the San Marcos River Retreat. We will e-mail the Zoom link with our next newsletter, for those who want to attend virtually.

## Election

Officers and board members of the TRPA serve two-year terms. Our By-Laws state: "Election of the officers and other members of the board shall be conducted by mail prior to the annual meeting in such a manner as the Board of Directors shall determine."

There is a ballot on the second to last page of this newsletter. It contains a list of nominees for officers and board members. There are also blank spaces to write in people for all offices and board positions. We will also be e-mailing a Google Forms ballot by February 15 to all paid members so they have the possibility to vote electronically.

Immediately prior to the annual meeting on Sunday morning, March 6, 2022, at 10 a.m. at the San Marcos River Retreat, members present will discuss any changes (like board members who have decided to retire) since the ballot was sent out. Members present will fill in their ballots and these ballots will be counted along with those ballots that have been received by mail or by Google. A committee selected from persons present at that time will count the ballots. Once the election is over, the annual meeting will begin.

If you intend to be present at the meeting on Sunday, March 6, please bring your ballot with you. If you cannot attend, but wish to vote in this election, make sure your does are current (paid within the last year) and either vote using Google forms or print out the attached ballot, fill it in and and either mail or e-mail it. Make sure that your dues are paid, and that the backside of the page either has your mailing label affixed or the application filled out. Your vote will be private, but we need to verify that everyone voting is a paid member, so we will look at the labels first (and/or check the e-mail return address), then all the ballots will be turned over and the votes privately counted.

To get to the San Marcos River Retreat: coming from Interstate 35 in San Marcos, get on Highway 80 and head toward Luling for 1.8 miles. Take a right on Old Bastrop (aka CR101, aka CR266 – it's the new traffic light right after the overpass). Take an immediate left onto county road 102. Go 1/2 mile on 102 and take a right on Pecan Park Dr. Keep going straight past Pecan Park Campground (on your left) and TG Canoes & Kayaks (on your right). # The Great Texas River Clean Up San Marcos River 37th Annual March 5, 2022

On Saturday, March 5, folks from all over Texas will be participating in the world's longest river clean up. We will be picking up trash along most of the San Marcos River (approximately 60 miles).

The City of San Marcos will hold their portion of the cleanup, walking the banks of the watershed and the sections of river within the city limits. **From San Marcos downstream (all the way to Luling - if we can)** canoeists, kayakers and rafters will be cleaning the river and the banks.

#### WHITEWATER PADDLERS

There are some sections of river that require whitewater skills. For those sections, only persons capable of handling a canoe full of trash in whitewater should volunteer. This is primarily for section 2, 7 and 8.

**CANOE RACING ENTHUSIASTS** Some sections of river, like Staples to Fentress and Stairtown to Luling have long stretches with few bridge crossings and for that reason, we are asking canoe racers (especially teams that have competed in the Texas Water Safari) to volunteer for those sections: sections 5, 7, 8 and 10.

She is an ACA River Canoeing Instructor Trainer and an Essentials of River Kayaking Instructor. She serves as a Merit Badge Counselor for the Canoeing, Kayaking, and Whitewater Merit Badges for the Scouts BSA program. She is a Section Leader for the San Marcos River and Medina River cleanups and participates in other cleanups as well. She has attended every one of the Medina River cleanups as a River Section Leader. She advocates for conservation and protection of both land and water and is a member of many environmental protection groups. Susan believes that people will value and protect only what they are familiar with, and that to save and preserve our rivers and our wilderness for future generations, we must introduce the current generation to the special places that Texas Rivers can take us.

**John Erskine** (Austin) is a die hard water nut and has been paddling and fly fishing on Texas Rivers for 35 years. David Price, PE (Austin), is the current President of TRPA. His technical expertise as a Registered Professional Engineer in wastewater (design, permitting, construction and operation) has helped TRPA win several major victories in the past couple of years, leading to ZERO, or almost ZERO discharge permits being granted by TCEQ. David's expertise in zero-discharge, large scale systems, has led the way on these permit revisions. He also has expertise in point, and non-point pollution, with emphasis on stormwater, and Edwards Aquifer recharge issues. David has led the TRPA organization since 2019. He spearheaded efforts on the approval of funds to construct a new (almost done!!!) website for TRPA, and was proud to work with many of the Board that stepped up to make the new site happen. David is an active boater, since 1977, and has run rivers on record flood stages, down to lakes and rivers you had to walk (Pecos flutes, anyone?), from the Piney Woods to Big Bend (and New Mexico, Georgia, Tennessee, and North Carolina). He was a Senior Canoe Guide, and instructor for UT Recreational Sports. He has a multitude of canoes, kayaks, and paddleboards (not to mention a couple of sailboats). Through his efforts as President of the Texas River Recreation Association, he organized and spear-headed the first large scale river cleanup in Texas, in 1979, on the Lower Guadalupe River, in which over 25 tons of trash was picked up in a single day, from Canyon Dam, down to Gruene. This resulted in a feature story in Texas Parks and Wildlife magazine. He has participated in many cleanups since that time. While with TRRA, he worked as a lobbyist in the Legislature, on Container Deposit Legislation. David is proud to build on the history of TRPA, and looks forward to continued work on water quality issues on Texas Rivers.

**Joe Rivers** (Houston) is an architect who and received a Bachelor of Environmental Design from Texas A&M University. He grew up canoeing the San Marcos and Guadalupe with his father. These early experiences instilled in him deep respect for the rivers and their conservation.
